WHEREAS, by interviewing the appropriate City personnel it was determined that the City DPW vehicle indeed made contact with and caused the damage to claimant's vehicle; and

WHEREAS, the claimant's insurance company sued the City and the matter was set for trial, the cost of trial would increase the cost significantly higher than the amount settled for hereunder; and

WHEREAS, the Corporation Counsel hereby recommends that the Board of Estimate and Contract approve the Settlement of the aforesaid claim in the amount of \$5,581.79; NOW, THEREFORE, be it

RESOLVED, that this resolution shall take effect immediately.


